Why I co-founded Cyverse AG in the Greater Zurich Area

- Cyverse AG emerged from St. Gallen MBA Thesis
 - "Swiss Venture Capital Investment in Israeli Cyber Startups A
 Critical Analysis," Shira Kaplan, July 2014
 - 7 trillion USD (25% of the world's wealth) managed in Swiss banks (Swiss Bankers Association);
 - There was a <u>big opportunity</u> to capture in terms of cybersecurity startups in Israel
- With Cyverse co-founder Anat Bar-Gera, we focused first on distributing next-gen Israeli cybersecurity technology to <u>large Swiss enterprises</u>
- Zurich is fantastic in so many ways efficiency of doing business, traveling around Switzerland and abroad, finding cybersecurity talent, Zurich's reputation of trust, security and privacy



A few unique features of the Israeli cyber-security ecosystem

- Constant flow of cyber-security / intelligence talent, coming from top army units (both men and women!)
- Ecosystem is fueled by Israeli **geo-political risk environment** (Crisis-mode/ urgency) that is fostering risk-taking & innovation
- Strong government support / championship for the Israeli cybersecurity ecosystem (cyber-security is a "growth engine")
- Strong presence of foreign venture capital funds in Tel Aviv (Sequoia, Bessemer, LightSpeed, Insight Partners etc. etc.), as well as local venture capital funds
- Culture of **openness, connectedness & information-sharing** (people do not keep information to themselves and that creates an ecosystem)
 - Social media
 - Technology sections on newspapers
 - Endless numbers of podcasts, blogs...
 - There's constantly a "buzz" around the Israeli cyber ecosystem
- <u>Cybersecurity in Israel is very sexy...</u> everyone wants to go into cybersecurity...







Key characteristics of an Israeli cyber-security startups

- Typically, 2-3 founders, who served together in the army
- Immediately face the **US market** (CEO usually relocates to the US within a year)
 - Sometime see the opportunity in **Europe**
- Seed round of **2-8 million USD** (backed by VCs and angel investors; spent on R&D)
- Series A round of **10-15 million USD** (backed by VCs and angel investors; spent on Sales & Marketing)
- Rapid expansion until **exit**, typically 3-5 years from foundation
